This petition has been filed for extension of time for compliance of the conditional order passed in CrI.O.P(MD).No.7273of 2025 dated 22.04.2025.

2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in CrI.O.P(MD).No.7273 of 2025 dated 22.04.2025 and enlarged the petitioner on Anticipatory Bail. The order copy made ready on 27.05.2025. Further, the petitioner is a daily wager and he is not able to arrange sureties and surrender before the concerned Court within the time stipulated by this Hon'ble Court.
