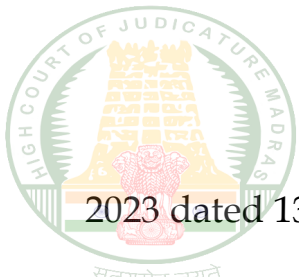
Prayer in WP(MD). 29571 of 2023 :
