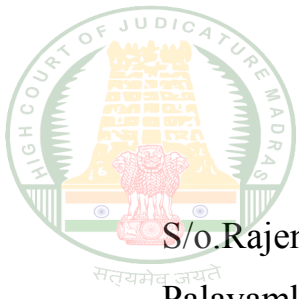

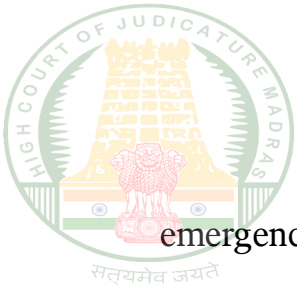
ORDER

3.When the matter is taken up for hearing today, the learned Additional Public Prosecutor appearing for the respondents, on instructions, submitted that the father of the petitioner sent a representation dated 22.02.2025 seeking
