2.The petitioner is intended to put up petrol pump. He has obtained all the certificates except No Objection Certificate from the respondent.

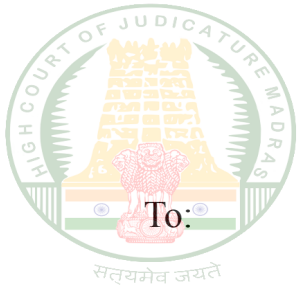
