ORDER

This writ petition has been filed seeking a direction to respondents 2 to 4 to survey and demarcate the petitioner's land, now comprised in T.S. No. 9/1, Theni Allinagaram Town, measuring 35 cents out of a total extent of 3 acres and 96 cents, originally in S. No. 196/1, Karuvella Nayakanpatti Village, Theni District, by disposing of the petitioner's representation dated 30.12.2024.

2. The petitioner seeks the indulgence of this Court to direct the respondents 2 to 4 to conduct a survey and demarcate the boundaries of the aforementioned property, as requested in his application dated 30.12.2024. Learned counsel for the petitioner submits that despite submitting the application, no action has been taken by the authorities. Aggrieved by this inaction, the petitioner has filed the present writ petition.

3. Learned Government Advocate appearing for respondents 1 to 3 submits that the petitioner's application will be considered on merits and in accordance with law.

There shall be no order as to costs.
