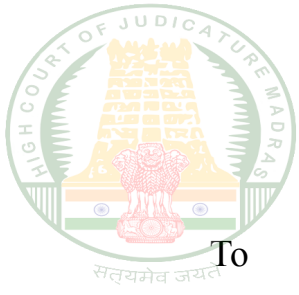
6.With the above direction, the Writ Petition stands disposed of.
