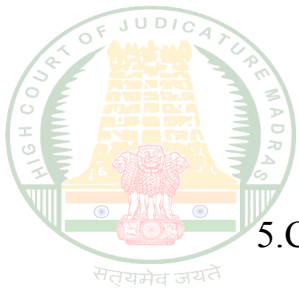
ORDER

This writ petition is filed challenging the impugned order dated 10.06.2025 passed by the first respondent vide his Proceedings in SCN/1049315225/25.

2.With the consent of both sides, the writ petition is taken up for final disposal at the time of admission.

3.It appears that the petitioner is arrayed as the second accused in Crime No.59 of 2019 dated 19.02.2019 for offence under Sections 294(b), 324 and 506(ii) of IPC.

4.The learned Government Advocate(Crl.side) appearing for the second respondent submits that the investigation has been completed and charge sheet has also been filed and the same has been taken on file in C.C.No.68 of 2024 before the learned Judicial Magistrate, Manamadurai.
