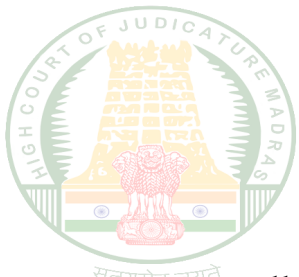
ORDER:-
