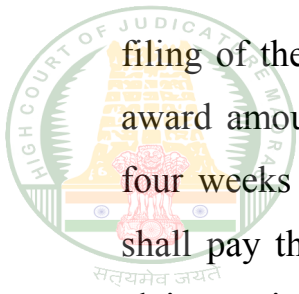

This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.I.Suthakaran and the counsel for the respondent No.1 Mr.S.Packiya Muthu, are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Aggrieved by the Award passed by the Tribunal, the appellant / Insurance Company has filed the present Appeal.

2. After due deliberations, both the parties have entered into compromise and agreed to modify the award amount to a sum of Rs.5,76,000/- (Rupees Five Lakhs Seventy Six Thousand only) with interest at the rate of 7.5% per annum from the date of



filing of the claim petition till realization. The appellant is directed to deposit award amount, after deducting the amount already deposited, if any, within a four weeks from the date of receipt of copy of this Award, failing which the appellant shall pay the Award amount together with interest at the rate of 7.5% per annum. The claimant is permitted to withdraw the award amount with interest by filing formal application before the Tribunal.

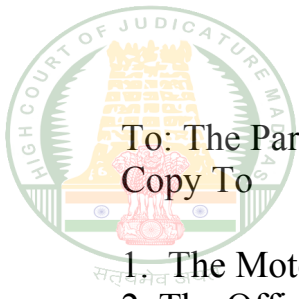
The Original of the award shall be place in the court record and copy of the award, kept with High Court Legal Services Committee and one copy each is furnished to both parties free of cost.
