2. Recording the endorsement made by the learned counsel for the petitioner, this Writ Petition is dismissed as infructuous. However, there shall be no order as to costs.

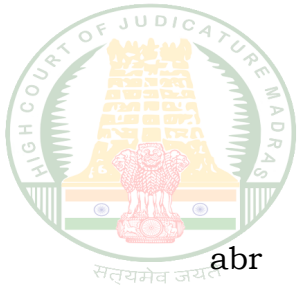
