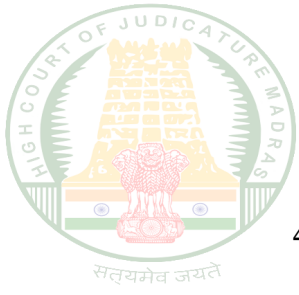
ORDER

2.The learned Counsel for the petitioner submits that the petition in CrIIMP.No.4764 of 2024 was filed on 23.09.2024 to refer the complaint to the respondent police for investigation, however it is not decided so far and the matter is periodically adjourned. Therefore, the petitioner is before this Court.

3.The learned Government Advocate (CrI Side) on instructions submits that the petitioner, who had filed the above petition, has not appeared before the court for enquiry on most of the hearings.
