ORDER

The present Writ Petition has been filed for the issuance of a Writ of Certiorarified Mandamus, to quash the impugned Refusal Number: RFL / Vadamadurai / 226 / 2023 dated 27.10.2023 passed by the 4th respondent and consequently, to direct the respondents to permit the petitioner to execute any transaction like sale, gift, mortgage, lease etc., with regard to his properties in survey number 1779/7C (Patta No.1306) situated at Kambiliampatti Village, Dindigul East, Dindigul District.

2.The contention of the petitioner is that originally, the land belonged to his ancestors. When the petitioner submitted a sale deed before the 4th respondent for registration, the 4th respondent refused to register the same stating

that it is temple land.

When it is a temple land, the 4th respondent is bound to conduct enquiry by calling the petitioner as well as temple and then pass orders as per the order passed in the case of ***Sudha Ravi Kumar and Another Vs. The Special Commissioner and Others*** in W.P.Nos.30589 of 2013 and batch, dated 05.04.2017.

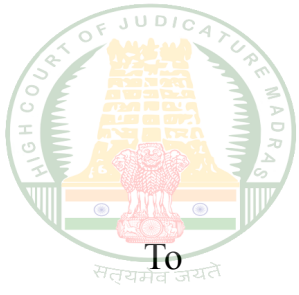
4. Therefore, the 4th respondent is directed to conduct an enquiry and pass orders in accordance to law.
