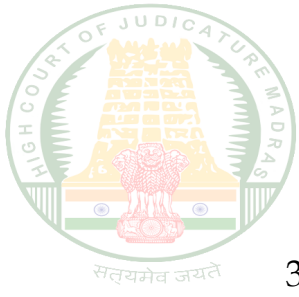
Prayer in WP(MD). 16664/ 2020 :
