ORDER

The petitioner is the accused No.2 in Crime No.3 of 2025 on the file of the respondent Police, which was registered for the offence under Sections 296(b), 115(2), 118(1), 351(3) of BNS. They have moved this petition seeking to quash the FIR in Crime No.3 of 2025 registered against him.

2. Today, when this petition is taken up for hearing, the learned Government Advocate (Crl. Side) submits that the investigation in Crime No.3 of 2025 was completed and the final report has also been filed before the learned Judicial Magistrate, Mudukulathur, through e-filing in No.C20250054 on 22.03.2025.

3. Since it is reported that the final report has been filed in Crime No. 3 of 2025, without ascertaining the materials relied on by the investigating agency in the final report, this Court is not inclined to proceed with the available FIR. Therefore, this Criminal Original Petition is dismissed with liberty to the petitioner to challenge the final report, if he is having any ground. Mere filing of the final report through e-filing is not sufficient. The
