PETITION FOR ANTICIPATORY BAIL Under Sec.482 of BNSS.

PRAYER :-

For Anticipatory Bail in Crime No.173 of 2025 on the file of the Respondent Police.

ORDER: The Court made the following order :-

The petitioner/A4, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 296(b), 118(1), 351(3), 3(5) of BNS and Section 25 (1 A) of Arms Act, 1959 in Crime No.173 of 2025 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that there existed property dispute between the petitioner's family and one Singaravelan's family. Due to which, there arose wordy quarrel between the petitioner and the defacto complainant on 11.06.2025, the petitioner abused the defacto complainant in filthy language and attacked him and also caused injuries. Hence, the complaint.

3. The learned counsel for the petitioner would submit that the petitioner is innocent and he has not committed any offence as alleged by the prosecution.

4. The learned Government Advocate (Criminal Side) would submit that the injured was discharged from the hospital and the investigation has been completed.

5. Considering the facts and circumstances of the case and taking into account of the fact that there existed property dispute between the parties and the injured was discharged from the hospital, this Court is inclined to grant anticipatory bail to the petitioner, subject to certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail in the event of

his arrest or on his appearance, within a period of fifteen days from the date of receipt of a copy of this order, before the learned District Munsif-cum-Judicial Magistrate, Alangudi, Pudukkottai District, on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the respondent Police or to the Police Officer, who intends to arrest or to the satisfaction of the learned District Munsif-cum-Judicial Magistrate, Alangudi, Pudukkottai District, and on further conditions that:

(a) the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(b) the petitioner shall furnish his residential address and mobile number to the learned District Munsif-cum-Judicial Magistrate, Alangudi, Pudukkottai District. In the event of any change in his residential address, the petitioner shall report the same to the learned District Munsif-cum-Judicial Magistrate, Alangudi, Pudukkottai District;

(c) the petitioner shall report before the respondent police daily at 10.30 a.m., until further orders;

(d) the petitioner shall not tamper with evidence or witness either during

investigation or trial;

(e) the petitioner shall not abscond either during investigation or trial;

(f) on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in *P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]*; and;

(g) if the accused thereafter abscond, a fresh FIR can be registered under Section 269 of BNS, 2023.
