This petition filed Under Section 528 of BNSS Act and 482 of Cr.PC, to call for the



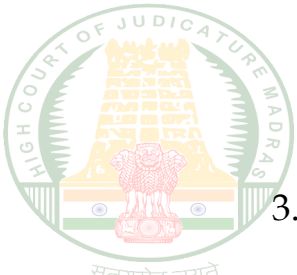
