(Order of the Court was made by **G.R.SWAMINATHAN, J.**)

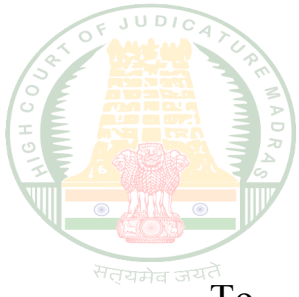
Heard both sides.
