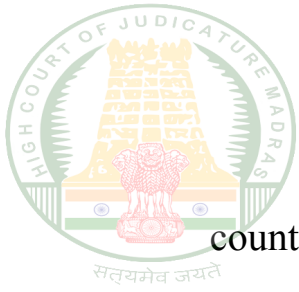

ORDER

2. The learned Additional Public Prosecutor submits that the complaint of the petitioner has been treated as petition enquiry in CSR No.157 of 2025. This complaint according to the learned Additional Public Prosecutor is lodged as a counter complaint to the complaint of one Gunasekaran. According to the learned Additional Public Prosecutor, the said Gunasekaran has lodged a complaint as against the petitioner, which has been registered in Crime No.74 of 2025 for the offence under Sections 294(b), 115(2), 118(1) and 351(ii) BNS. 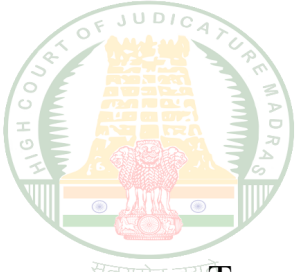
