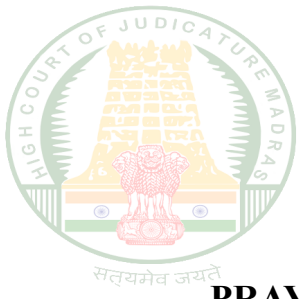

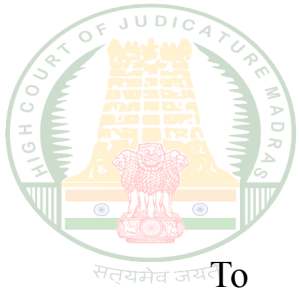
### **ORDER**
