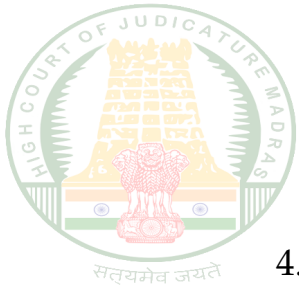

2. Alleging that the husband of the petitioner namely Sathiyamoorthy aged about 28 years was taken to illegal custody by the special team of police and subsequently his whereabouts is not known, the present petition has been filed before this Court.

3. When the matter is taken up for hearing today, the learned Additional Public Prosecutor submitted that the husband of the petitioner is a habitual offender involved in several cases in various police stations in Madurai District and that he was arrested at 05.15 pm., on 26.06.2025 near Puttuthoppu Sivankovil, Madurai District in connection with Crime No.336 of 2025 registered for the offence under Section 310(4) of BNS and he was remanded to judicial custody by the learned Judicial Magistrate No.V, Madurai. He would further submit that he is not under illegal detention of anybody and the said arrest was also intimated to one of his friend namely Vijayakumar.

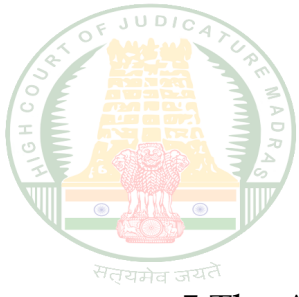
