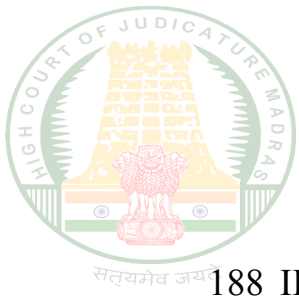

The learned Government Advocate (Crl. Side) undertakes that the final report would be filed as against the petitioner and other accused, within a period of one week from today.
