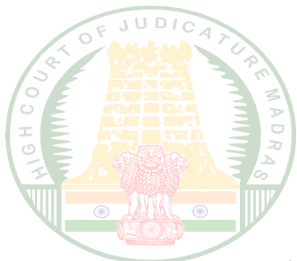

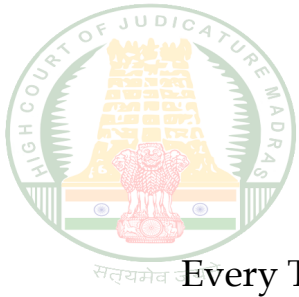
This petition has been filed to modify the condition No.6(d) imposed on the petitioner in Crl.OP(MD).No.9980 of 2025 dated 16.06.2025.
