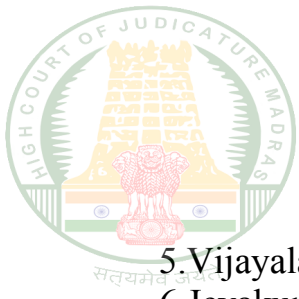

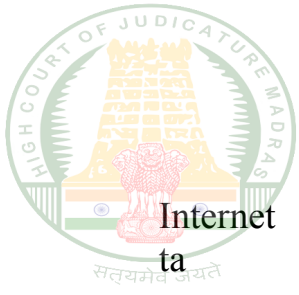
ORDER
