ORDER : The Court made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent police for the offences punishable under Sections 318(4) of BNS in Crime No.Not Known of 2025, seeks anticipatory bail.

2. Today, when the matter is taken up for hearing, the learned Government Advocate (Criminal Side), on instructions, submitted that the petition enquiry is pending against the petitioners (CSR.No.178 of 2025).

3. The learned Counsel for the petitioners submitted that the respondent police is harassing the petitioners under the guise of enquiry.

5. Till such time, the petitioners shall not be arrested by the respondent police.

6. With the above directions, this criminal original petition is disposed of.
