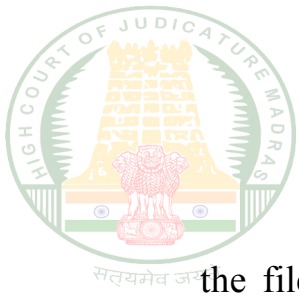

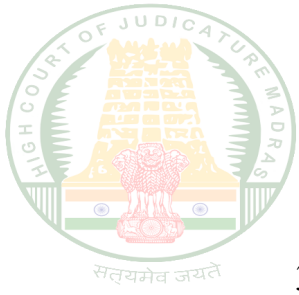

JUDGMENT
