Thus, the order under Section 6 of the Tamil Nadu Land Encroachment Act, 1905, has been issued. If at all the petitioner is aggrieved, he is at liberty to prefer Section 10 of the Tamil Nadu Land Encroachment Act, 1905.

4. With these observations, the writ petition stands dismissed. No costs. Consequently, connected miscellaneous petition is closed.
