ORDER

The petitioner has submitted a representation to the respondent police on 09.04.2025, to recover the property in S.No. 69/38, Nilgiri South Thottam Revenue Village, Thanjavur District, which according to the petitioner is in illegal possession of the fourth respondent and filed this writ petition to issue a direction to the third respondent police to consider his representation, dated 09.04.2025.

2. It appears that there is a civil dispute between the petitioner and the fourth respondent, over the property in S.No. 69/38, Nilgiri South Thottam Revenue Village, Thanjavur District. The respondent police cannot interfere in such matters and hence, this Court also cannot issue any direction to the respondent police to act upon the representation of this petitioner, dated 09.04.2025. 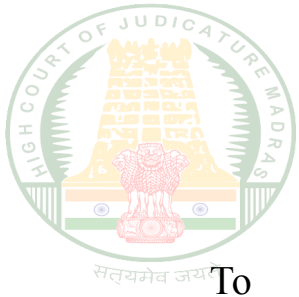
