ORDER

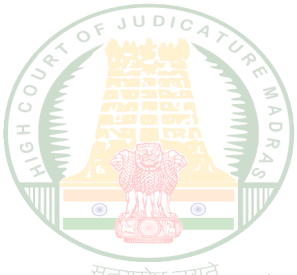
[Order of the Court was made by A.D.JAGADISH CHANDIRA, J.]
