This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.A.V.B.Krishnakanth and the counsel for the respondents Mr.N.Madhava Govindhan are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

After discussion and negotiation, the appellant / Transport Corporation and respondents / claimants agreed for a sum of Rs.28,00,000/- (Rupees Twenty Eight Lakhs only) as full quit. The appellant / Transport Corporation has already deposited a sum of Rs.11,99,500/-.

The appellant/Transport Corporation is directed to deposit the balance amount of Rs.

16,00,500/-(Rupees Sixteen Lakhs and Five Hundred only)[Rs.28,00,000/- (-) Rs.11,99,500/-]



award amount within a period of ten weeks from today. On such deposit, the respondents /
claimants are entitled to withdraw their share as apportioned by the Tribunal, less the amount
already withdrawn, if any.
