### **ORDER**

2. The petitioner has made an application for issuance of FL-2 licence in Form-F.A1.2 on 08.01.2025. The petitioner has also sent a representation on 25.01.2025, followed up by a reminder dated 18.06.2025 for issuance of FL-2 licence. However, the same has not been considered till date.

3. It is noticed that the Superintendent of Police has also given no objection for issuance of FL-2 licence to the petitioner in his proceedings dated 20.01.2025 bearing reference in ந.க.எண் ஜி1/1107/02/2025.

4. Considering the same, there shall be a direction to the first respondent to consider the aforesaid application dated 08.01.2025 in Form-F.A1.2 of the petitioner under the provisions of the Tamil Nadu Prohibition Act, 1937, as
