ORDER

The instant contempt petition has been filed alleging wilful disobedience of the order of this Court dated 24.04.2025 passed in WMP(MD) No.8686 of 2025 in W.P.(MD) No.11770 of 2025.

Hence, there is no willful disobedience of the order of this Court and hence, this contempt petition stands closed.
