3. Recording the same, this Criminal Miscellaneous Petition is dismissed as withdrawn.

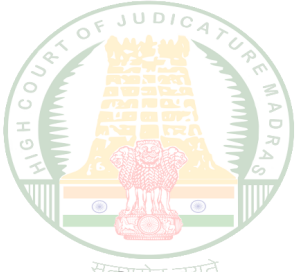
