The case, which was registered as against these petitioners along with A1 is pending before the Additional Mahila Court, Dindigul in PRC No.54 of 2025. The petitioners have filed an application to quash the above proceedings and filed this Miscellaneous Petition to dispense with the personal appearance of these petitioners before the trial Court.

3.Issue notice to the second respondent returnable in three weeks. Private notice is also permitted. Post the matter **after three weeks**.
