ORDER

The petitioner herein seeks a direction to respondents 1 and 2 to consider her application No.2025/0123/13/012163, dated 13.05.2025, to conduct survey of the property situated in Survey Nos.344/1, 344/2, 344/3, 344/4, 344/5, 344/6, 352/5B1, 353/1, 353/2, 353/3, 354/1C, 354/1D, and 343/1E, at Marambadi Village Vedasandur Taluk, Dindigul District, by considering her application, dated 13.05.2025.

2. According to the petitioner, the subject property belongs to her and the revenue records stand in her name. On the strength of the revenue records, she submitted an application before the respondents 1 and 2 on 13.05.2025 in Application No.2025/0123/13/012163, seeking survey of the

In view of the above, without expressing any opinion on the merits of the matter, respondents 1 and 2 are directed to consider the application submitted by the petitioner, dated 13.05.2025, and pass final orders on its own merits within a period of fourteen weeks from the date of receipt of copy of this order, after issuing notice to petitioner, fourth respondent, neighbouring land owners, and other interested parties.

5. Accordingly, the Writ Petition stands disposed of. No costs.
