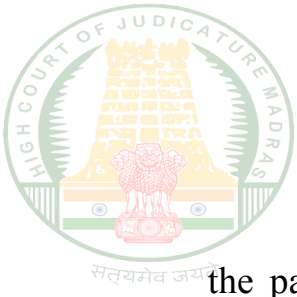

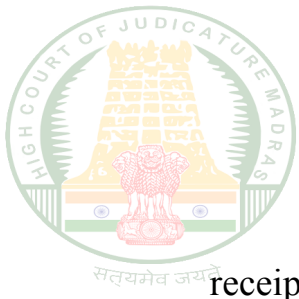
disposal at the admission stage itself.

4. According to the petitioner, the subject property was settled in favour of the petitioner by his brother, Mohamed Sharuk, under a registered settlement deed dated 16.06.2021. Subsequently, patta was also issued in the name of the petitioner, as per the order passed by the Zonal Deputy Tahsildar, Pudhukottai, dated 14.10.2023. The petitioner submitted an online application on 09.06.2025 in Application No. 2025/0178/21/00075, seeking survey of the subject property. The same has not been considered.
