COMMON ORDER

When the matter came up for hearing, the learned counsel appearing for the petitioner submitted that both the parties appeared before this Court and both the parties entered into compromise. He further submitted that the petitioner husband has paid a sum of Rs.25,00,000/- by way of demand draft to the respondents. The first respondent has also acknowledged the receipt of Rs.25,00,000/- on behalf of herself and two minor children. A terms of compromise memo in this regard has also been filed.

2. Accordingly, these Criminal Revision Cases are disposed of. The terms of compromise memo shall form part of this order. The impugned orders passed by the learned Trial Court are hereby set aside. It is also made clear that all the criminal cases lodged against the petitioner husband is hereby quashed invoking inherent powers of this Court. The disciplinary proceeding initiated against the petitioner husband will automatically go. No Costs. Consequently, connected miscellaneous petitions are closed.
