ORDER

2.Mr.P.Kottaichamy, learned Government Advocate, who takes notice for the respondent submits that the investigation in Crime No.100 of 2022 has already been completed and the final report has also been been filed before the Judicial Magistrate Court, Pudukkottai on 05.05.2025, through e-filing, however, the same is yet to be taken on file.
