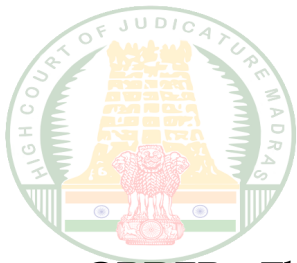

This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P.(MD).No.5728 of 2025 dated 22.04.2025.

The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P.(MD).No.5728 of 2025 dated 22.04.2025 and enlarged the petitioner on anticipatory bail with certain conditions. Due to the financial condition of the petitioner, he unable to surrender the sureties before the concerned Court within a time as stipulated by this Court.
