ORDER

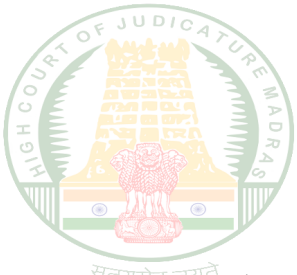

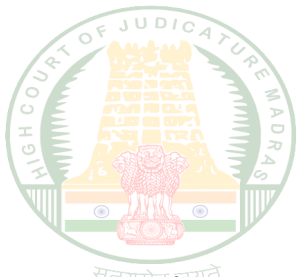
