2. On instructions, the learned Additional Government Pleader would submit that no tamarind trees have been cut down. As regards the consequent relief, the petitioner shall make a fresh online application to the 2nd respondent.

3. In view of the submissions made by the learned Additional Government Pleader, the petitioner is directed to make a fresh application online to the 2nd respondent and on receipt of such application, the 2nd

The said exercise shall be completed within a period of two (2) months from the date of receipt of copy of this order. It is needless to state that, in the interregnum, no trees shall be cut down.
