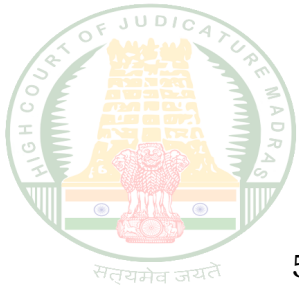

The learned counsel for the petitioner submitted that he was not able to comply with the order passed in Crl.M.P.No.1184 of 2025 dated 30.04.2025 and Crl.M.P.No.1520 of 2025, dated 06.06.2025, because of the fact that the petitioner suffered from Jaundice at that point of time.
