This petition has been filed for extension of time for compliance of the conditional order passed in CrI.O.P(MD).No.9337 of 2025 dated 05.06.2025.

2. The learned Counsel for the petitioners would submit that this Hon'ble Court passed an order in CrI.O.P.(MD).No.9337 of 2025 dated 05.06.2025 and enlarged the petitioners on anticipatory bail. The petitioners are economically weaker section and they are unable to mobilize fund to deposit the money and to surrender the sureties before the concerned Court within a time as stipulated by this Court. For the said reason only, the petitioners are unable to comply the conditions imposed by this Court in CrI.O.P.(MD).No.9337 of 2025 dated 05.06.2025.
