The Criminal Miscellaneous Petition has been filed seeking orders to modify the condition imposed on the petitioner by this Court in its order, dated 04.04.2025, made in Crl.M.P(MD)No.1900 of 2024 in Crl.A(MD)No.130 of 2024, directing the petitioner to produce two sureties, who are respectable persons in the society, in order to ensure the conduct and the availability of the petitioner during the appeal proceedings.

2. Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Criminal Side) appearing for the State.

3. The learned counsel appearing for the petitioner would submit that the petitioner has produced the sureties including the Corporation Employee, but the learned trial Judge has returned the same saying that they are not respectable person. He would further submit that the petitioner's mother and sister are ready to stand as sureties for the petitioner.
