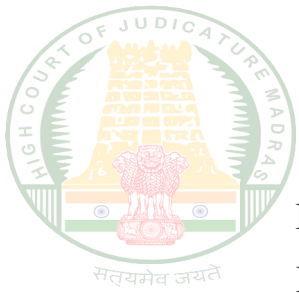

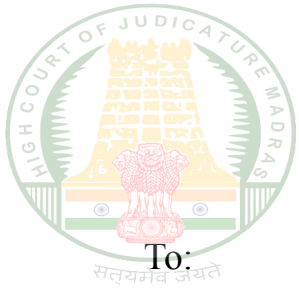
2. Admittedly, the petitioner is a tenant under the third respondent herein. Therefore, a Writ of Mandamus is not maintainable.
