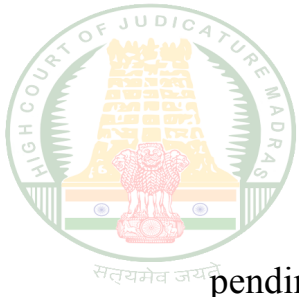
ORDER

The writ petition has been filed challenging the impugned show cause notice in Na.Ka. No.18289/2017/K3-1 dated 19.16.2024 issued by the first respondent.
