ORDER: The Court made the following order :-

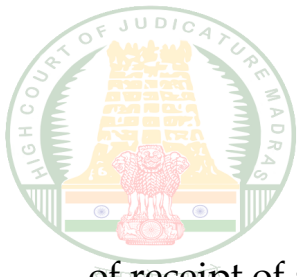

2. The learned Counsel for the petitioner would submit that this Hon'ble Court has passed an order in CrI.O.P.(MD).No.9309 of 2025 dated 11.06.2025 and enlarged this petitioner on anticipatory bail with certain conditions. Due to the petitioner's ill-health, he is taking treatment for cancer. Hence, he is unable to execute the bond and not able to arrange sureties and produce before the concerned Court. For the said reason only, he is unable to comply the conditions imposed by this Court in CrI.O.P.(MD).No.9309 of 2025 dated 11.06.2025. Hence, he prayed to extend the time period, by allowing this Criminal Miscellaneous Petition.
