3. By consent of both sides, this Writ Petition is taken up for final disposal at the admission stage itself.

4. According to the petitioner, he purchased the property under registered sale deed, dated 18.06.2012 and the patta for the subject property also stands in his name in patta No.3983. He submitted an application on 09.04.2025 in application No.2025/0123/26/007244, seeking survey of the subject property. The said representation has not been considered. Hence, the petitioner has come before this Court.

5. The learned Additional Government Pleader, who takes notice for the respondents 1 to 3 would submit that the petitioner's application will be considered in accordance with law.

6. In view of the same, without expressing any opinion on the merits of the matter, the respondents 2 and 3 are directed to consider the petitioner's application, dated 09.04.2025 and pass final orders on its own merits, within a period of eight weeks from the date of receipt of copy of
