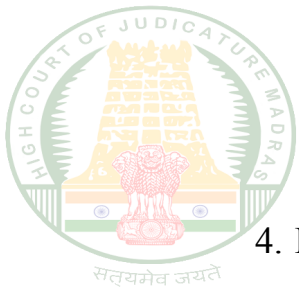

### **ORDER**

The petitioner seeks issuance of writ of mandamus to direct the respondents to comply with the order, dated 15.01.2016 in W.P.(MD)No.24001 of 2016, by conducting fresh enquiry and identify beneficiaries.

2. The Special Tahsildar (Land Acquisition), Adi Dravidar Welfare, Srivilliputhur is *suo motu* impleaded by this Court.

3. The learned Special Government Pleader submits that even in the earlier order, dated 15.01.2016 in W.P.(MD)No.24001 of 2016, this Court only directed necessary enquiry to be conducted and orders to be passed thereafter. He would therefore submit that suitable direction can be issued to the 5<sup>th</sup> respondent.

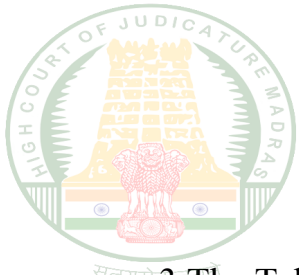
5. With the above direction, this Writ Petition stands disposed of. No costs. Consequently, connected Miscellaneous Petition is closed.
