ORDER : The Court made the following order :-

This petition has been filed to relax the condition imposed on the petitioners in CrI.OP(MD)No.5225 of 2025 dated 16.04.2025.

2. The learned counsel for the petitioners submitted that since the petitioners were affected by food poisoning, they were unable to appear before the respondent police and comply with the condition from 21.06.2025 to 27.06.2025 due to their health condition. Thereafter, from 28.06.2025 till date, the petitioners have been complying with the condition imposed by this Court regularly, and he prays for relaxation of the said condition.

3. The learned Government Advocate (Criminal Side) submitted that the

5. With the above modification, this Criminal Miscellaneous Petition is allowed.
