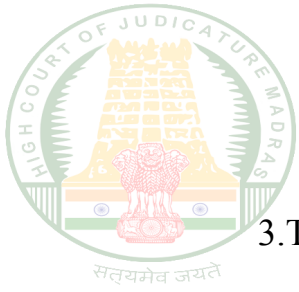

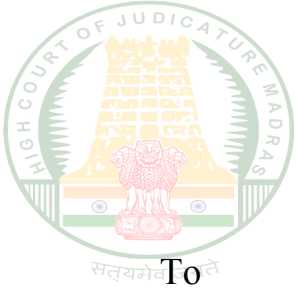

4.In view of the encroachment having been identified, it is for the official respondents to take appropriate action as per the provisions of the Act and Rule to remove the encroachment.

5.Accordingly, this Writ Petition is disposed of with a direction to the official respondents to pursue with the enforcement action as per the provisions of the Act and Rule and complete the same within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
